Concordia's WHY/Purpose Statement

To be welcoming and inviting community empowered by the Word of God; So that we may work for social justice and exhibit compassion for all. When you receive this issue of The Concordia Chimes, it will be June (or at least close to it). But as I write this, it is still May precisely May 12—so I am not in June yet. I am sitting in the office at Concordia, looking out the window at a clear, cloudless blue sky. Checking the weather app on my phone, I see that it's a comfortable 67°, with a projected high around 72°. But the low at my house in Wilbraham this morning was 36°.

Now, I know you aren't reading this article for a weather report, but please keep the above in mind. The very first thing I do when I get up in the morning is check the weather app—for temperature, rain, snow, or sunshine. Why? Habit, to a large extent. But it also guides me in choosing what to wear—sweater, jacket, long-sleeve shirt, short-sleeve shirt, etc. I have begun to switch over to short-sleeve shirts, but this morning, it was so cool in Wilbraham that a flannel shirt was in order.

Two thoughts come to mind regarding clothing choices. First, I am lucky, blessed, and fortunate to have options, when so many people do not. I suspect that many of you reading this letter are blessed in the same way. The only day that I have no choice in what to wear is Sunday morning, when I have just two options—a black or a gray clerical shirt, or sometimes a light blue one for summer. But there is something even more important than what we wear, and it comes to us under the aegis of baptism. In some traditions (and it can be part of our Lutheran tradition as well), a baby wears a white baptismal garment, which symbolizes putting on Christ in baptism. And that is where we end.

Regardless of the weather—and despite what we need or choose to wear on a given day—we must remember that, in and through baptism, we are clothed in, with, and by Christ every moment of our lives. And this does not depend on the weather!

# Transition Update from Mark Winzler

Dear Sisters and Brothers in Christ,

Since the vote was taken on April 27, 2025 to explore Holy Closure, I have communicated with those who are or were affiliated in some way with Concordia: former pastors and those groups/churches/organizations who use our building space. Associate to the Bishop Pastor Maria has informed Bishop Pipho and other members of the Bishop's staff.

Last evening (Monday, May 5) Pastor Maria met with members of the Council and Transition Team. The purpose of the meeting was for Pastor Maria to review and answer questions about a) the two-page *Holy Closure Process* document and b) the *Covenant for Congregations in the Holy Closure Process* document and c) to begin making some plans as a result. (These were sent out to all members previously, hence you should have copies of them.)

The following is a brief synopsis of the things that we discussed. The purpose is to provide some general information and dates to put on your calendars. More specific and detailed information will be forthcoming as we move forward in the process.

#### Please put the following dates in your calendars:

#### 2025 Dates

#### Semi-Annual Meeting - Sunday, June 22, 2025

This is our regular June semi-annual meeting for program where we will review the reports. At this meeting, Pastor Maria will be present as <u>one of the first things that we must do is for the</u> <u>congregation to vote to put the building on the market and set preferences</u> (sell to another church? Sell to a non-profit? Sell to Developer). These are preferences but will be open to all offers and all will be considered.

#### Memorial Garden Worship - Sunday, September 7, 2025

With thanks to Memorial Garden Board, some advance work has been done over the past couple of years to prepare in case Concordia would merge or close. Two plots were purchased at East Cemetery for remains to be transferred. The families of those who had relatives interred in the Garden (or those who had planned to be interred) were contacted asking whether they would wish the remains to be brought there or returned to them. On this Sunday (the date is tentative), we will move to the Garden for the end of the worship service to begin the process of the remains to be moved.

#### 2026 Dates

#### **<u>Celebration of Ministry Worship Service and Reception - Sunday, June 7, 2026</u></u>**

This worship service is meant to be just that: a celebration of the ministry of Concordia over the years. This is the service we invite back our former pastors, former Ministers of Music, former members, other churches, town officials etc. The worship will be "Easter-like" and where we "pull out all the stops". This service will be held in <u>the</u> afternoon (no morning worship this day) so that others can join us. There will be a festive reception in Kaiser Hall after the worship service.

## Service of Leave-taking - Sunday, June 28, 2026

This will be our last service in our sanctuary. As part of that service, the church will be decommissioned as our worship space. This is a time just for present members. Most likely following this service we will go to a nearby restaurant/banquet facility for a final meal together.

#### **Other Items of Note**

#### <u>Covenant</u>

Motion was made, seconded and passed unanimously to approve the *Covenant for Congregations in the Holy Closure Process* with the New England Synod.

#### <u>Teams</u>

One of the things we need to do is to form teams: **Real Estate Team, Property Team, Archives Team, and Finance Team**. Please think about where your interests might lie and where you might like to serve (<u>Refer to the two-page document sent earlier for descriptions of the work of each team</u>.) We will be reaching out to ask your preference in the near future.

#### Social Events

There has been some interest expressed in having a series of social opportunities for members of Concordia to be together between now and the closing. If you are interested in being part of a planning group, please contact Margie in the Church Office to let her know. (Please note that this group will be the "worker bees" and not planning things for other people to do.)

#### Pastor Hedberg

This September will mark four years since Pastor Hedberg began as our transition pastor. Normally transition pastors serve for 1-2 years only. Therefore, he has gone "above and beyond" what is the norm.

Pastor Hedberg informed us last evening that, as he has in the past year, he will be away for the months of July and August (except for one Sunday) and while he will come back in September, he will only continue to serve Concordia up to and including Christmas (2025). <u>He will not return after Christmas.</u>

He emphasized to us that it has absolutely nothing to do with us as both Lois and he love being at Concordia and love all of us. It is to do with the fact that he is getting (and feeling) older and the commute from Wilbraham, MA is beginning to wear on him. Couple that with the desire to spend more time at their place in northwest MA as well as time with their grandchildren.

Pastor Maria (who will attend Council Meetings beginning in January, 2026 through the closing) and I will come up with a plan for Sunday worship coverage as well as pastoral care for the time after Pastor Hedberg leaves us. We will celebrate his ministry before he leaves!

#### Covenant for Congregations in the Holy Closure Process – Signed May 5, 2025

The Congregation Council unanimously passed signing this Covenant at their meeting with Pastor Maria on Monday, May 5. This Covenant was previously shared with all members of the congregation in a couple mailings.

Cavenant for Congregations in the Holy Closure Process After prayerful consideration and engagement with our congregation, we have contacted the New England Synod and requested the resources and assistance to begin the prayerful and deliberative process of concluding our ministry and making plans for our legacy. As we enter this process, we understand and agree. The fees and services of Brad Cook, New England Synod Attorney and Partner at Sheehan Phinney Law Firm, will be paid directly from the assets of this congregation. We understand that Attorney Cook is offering his services at a discounted rate to New England Synod congregations. We will sign a letter of agreement, which will be provided by Attorney Cook, and retain his services as a part of this Holy Closure Process. We will set aside \$5,000 for the Region Seven Archives in Philadelphia to secure this congregation's records and sacred documents as a part of our legacy unless we choose to contact our local historical society and plan with them. If costs are incurred with the local historical society, we understand it is our responsibility. achicaponces We will set aside at least 10% of the legacy assets for the Congregational Care Fund, which supports the work of assisting other congregations of the New England Synod as they enter In addition, we will prayerfully consider gifting a percentage of our legacy assets to the New England Synod Mission Development Fund, which starts new congregations We will make use of the New England Synod's Legacy Planning document as a guide for the planning and distribution of our assets, in conjunction with the Legacy Workshop led by Pastor Maria Hammons - Associate to the Bishop for Missional Discernment and Legacy. As part of our legacy giving process, we will abide by both the Internal Revenue Service guidance, as well as understanding that our assets are a legacy of a Word and Sacrament centered ministry of the Lutheran Church founded to serve the mission of Jesus. The March 2025 treasurer's report was distributed, reviewed and received. We continue to meet our obligations, our investments show a loss year to date for the first time this year, due to this month's losses.

#### **Old Business**

The nominating committee continues to work to find people to fill openings on committees and boards.

### New Business

A motion was made and passed to forward to the congregation on April 27<sup>th</sup> to following:

### Resolved: Concordia's Congregation Council recommends to the congregation of Concordia Lutheran Church in Manchester CT, to vote to explore the Holy Closure process, which will include discussion about Concordia's legacy, the sale of the church building and property, and final dissolution of Concordia.

Our existing secure door policy was reviewed in connection to research done by property. It was decided that we keep the existing policy in place and install a few white boards to make access phone numbers easier to display and modify.

A DRAFT ICE policy was reviewed and accepted to be implemented as modified. Updates will be made and the policy distributed. Motion: **To implement the ICE policy as modified.** 

An additional donation of approximately \$2,700 was received from the Carol Sutcliffe estate. A motion was passed to distribute 10% of the funds for outreach to Highland Park School.

Motion: To purchase gift cards totaling \$270 (10% of the \$2,700 of Carol Sutcliffe Bequest) to provide to Highland Park School to assist families in need. <u>Property</u>

The organ repair is partially completed.

The following is an excerpt from a sermon I wrote based on Luke 4:1-13. I hope you enjoy it.

#### Sermon title: **Get Out of Here Devil**! By: David Smith

It seems to me that some people spend their entire lives in the wilderness being tempted by the devil. Those who are strong in faith can resist it and keep their vision on matters of the spirit and doing what they feel God wants them to do. There is an ominous verse at the end of today's gospel where the devil stops tempting Jesus and will wait for an opportune time. The devil is likewise always looking for an opportune time in our lives and we must guard against that. Attending church regularly is a good way to ward off the devil's temptations because it keeps us grounded, and on track, and hearing the gospel message to retain the spirit in our lives to remain in a positive direction.

My week always goes better when I attend church as compared to the weeks when I cannot attend. Going to church doesn't mean all your problems will be solved, but it does mean you can gain the spirit that we all share, so we're at least able to address the choices ahead more rationally with strength to stay on the Lord's path and not the devil's. The devil is waiting to tempt you, to find you when you're tired or weakened in spirit, to suggest the absolute worst things to do, and to get you to justify it, even if it means hurting others that may be relying on you.

I can attest to the temptations and urges that are there. It's not only the devil trying to get you to do more and more, and do things to obtain more and more, not caring about anyone or anything else, but also your body giving the urges as well. It is only through the spirit you will be strong enough to fight back and overcome it. It is not easy. We all dig our own ditches. Some you can hop out of with a quick correction and others will require a significant amount of work, and sacrifice, to get back on solid ground. That's the important work we all must do when we succumb to temptations—rather than avoiding the wrong path in the first place.

Few people can claim they have the perfect life. There are always some struggles in everyone's life. There are also things that happen that can upset an otherwise great life and provide serious challenges. For example, I have a friend that suffered a brain aneurism that plunged him into over two years of recovery and therapy and completely derailed his life and his family's for an extended period. Things happen. There is a lot of randomness out there, so staying grounded in the spirit, and coming to church to worship Jesus as part of a congregation where we pray for each other, pray for Jesus to be in our lives and watch over us, and help each other when we need it, goes a long way to bolster us in times the devil would otherwise have an opportunity.

Keep strong in the spirit of the Lord to always be in the position to rebuke the devil when he finds an opportunity. When in dispute, pray to the Lord, and reach out to anyone in church for help. We're here to support each other and to help others. It can be easier said than done, but it's always better to be able to say, get out of here devil! You are powerless over me. I'm with Jesus! This is my church.







- 40+ GHIAA leaders showed up for the May Day Celebration of Power, Love, and Resistance in Bushnell Park.
- On May 15 we had an Interfaith Advocacy Day at the Capitol in support of the expanded Trust Act. There was a press conference at 10:30 am, and then we connected with legislators to seek support for expanded protections against ICE overreach in our state.

#### **Fiscal Policy**

The next step in our campaign to reform the "fiscal guardrails" and create a moral budget that truly invests in our communities is to bring our voices to Gov. Lamont's attention. We are urging people to

contact the governor

by phone and email with this message: "Please declare a fiscal emergency, lift the guardrails, and build a budget that responds to the human needs that already exist in our state and addresses the potential losses due to federal cuts."

 We are working on details for upcoming public actions.

#### Just Cause Eviction Protections

- We continue to add cosponsors in support of the **Just Cause eviction** protections bill, which helps to build momentum and pressure to bring the bill to a vote and pass it. If your legislator has not yet cosponsored (you can look for their name at the bottom of the **bill website**), you are encouraged to contact them and ask for their support. The bill has been vetted in caucus, has 57 co-sponsors, and is ready for a vote, but we need House leadership to bring it to the floor.
- On May 8 GHIAA joined allies from the CT Tenants Union for a press conference supporting Just Cause during Seniors Day at the Capitol.

#### Hartford North End Public Safety Summit

• GHIAA leaders and neighbors in Hartford's North End have been engaging deeply for many months in community visioning for public safety. The 2025 North Hartford Public Safety Summit: "From Vision to Action" was held on May 13, building on that community visioning to shape leadership, strengthen trust, and advance equity in policing.

#### **Combating Racial and Religious Hate**

• Session 3 of the "Broadening Understanding, Deepening Solidarity" training series was held on May 6. We focused on stereotypes, tropes, and microaggressions. The <u>Micropedia of Microaggressions</u> is an excellent resource for learning more.
